ESTABLISHMENTS ISSUED VIOLATION TICKETS

The Supplies Control Unit (SCU) in the Ministry of Agriculture, Food Security and Enterprise hereby informs the general public that since the launch of its compliance activities, several establishments have been cited for violations of the new Supplies Control (Prices) Regulations as per the list below. Establishments listed and highlighted in bold indicate that the establishment was issued multiple tickets.

Several matters remain under review, and the public will be notified of the findings in due course. The unit wishes to inform the public that the following additional measures have been put in place to expand coverage and improve compliance with the regulations:

- 1. Engagement with NEMO San Pedro to train designated persons to identify violations and issue tickets, especially in times of emergency. A training package has been developed, and training sessions are to be completed.
- 2. Engagement with the Belmopan City Council to report violators to the Trade Licensing Board and identify means of facilitating residents with filing complaints.
- 3. Approval of additional personnel and the opening of regional offices in the Orange Walk District and Independence Village.
- 4. Expansion of surveillance activities to the wholesale segment of the distribution chain.

These measures reflect the Ministry's commitment to the enforcement efforts aimed at minimizing violations and ensuring that consumers' interest are protected.
